All bail bond agents/agencies who desire to write bail bonds in the Shaker Heights Municipal Court must register with the clerk's office before a bond may be filed in this court. All current registered agents/agencies are listed on the court's website. To register, an agent/agency shall file a certified copy of the agent/agency's appointment by power of attorney from each insurer the agent/agency represents for each licensing renewal period.

The Qualified Bail Bondsmen List will be updated on an as needed basis.

Bail Bondsmen who wish to be added to the list need to submit their qualifying power of attorney to the Clerk of Court during normal business hours.

Bondsmen are encouraged to bring a copy of the list with them when posting bonds.
