## Shaker Heights Municipal Court Instructions

### REQUIREMENTS FOR FIRST OFFENDERS WITH

### RESPECT TO OVI AND RELATED OFFENSES

You have been charged with or convicted of the offense of Operating a Vehicle while Under the Influence of Alcohol and/or a Drug of Abuse, commonly referred to as "OVI," or another offense for which the Court has certain requirements that must be completed prior to a change of plea or completed as part of your sentence.

**Before you appear for your next court date there is a requirement that you complete a Driver's Intervention Program within the next 12 weeks.**

### DRIVERS INTERVENTION PROGRAM REQUIREMENT

If this is your first OVI or offense reduced from OVI (for example reckless operation or physical control), the Court will require you to complete a 72-hour Driver's Intervention Program (DIP). DIP programs are certified by the Ohio Department of Mental Health and Addiction Services and usually held at hotels. During the DIP, participants receive instruction on traffic safety, alcohol and drug abuse education, and counseling. Some DIPs also provide other services like alcohol and drug assessments.

If your next court date is a "Change of Plea and Sentencing Hearing," the Court will permit you to complete the DIP instead of sentencing you to jail. If your next court date is a "Probation Status Hearing," the Court is requiring you to complete a DIP instead of sentencing you to jail. **YOU MUST COMPLETE THE DIP PROGRAM WITHIN THE NEXT 12 WEEKS.** A list of DIPs in Cuyahoga County and surrounding counties is attached to this packet. **YOU are required to do the following:**

1. Contact a DIP and sign up for it by paying the fee.
2. Attend, participate in, and complete a 72-hour DIP.
3. Obtain a certificate of completion from the program.

5. Make sure that the DIP *faxes* a copy of the certificate of completion AND the DIP completion report to the Probation Department at 216-491-1385
6. **BRING A COPY OF THE CERTIFICATE WITH YOU TO COURT ON THE DATE WRITTEN ON THE FIRST PAGE OF THIS PACKET.**

If it is determined by the DIP that you require additional treatment or supervision, you will later be placed on active probation to help you complete these requirements.

If you prefer to serve 3 days in jail, you do not have to complete the DIP. If you have not completed the DIP by the time of your next court date, you will be referred to the Probation Department to schedule your 3 days in jail.

## **YOUR NEXT COURT DATE**

You must return to court on the date written on the first page of this packet. When you come to court you must bring your certificate of completion of the DIP.

\*Fines and costs are due on the date of your next court date. It may be possible to apply your bond money towards payment of your fines and costs.
